PROGRAM OVERVIEW

Pacific's Master of Science in Finance (MSF), offered by the Eberhardt School of Business, is a STEM-designated and hyflex program designed to prepare students for intense competition in the finance profession. The curriculum also prepares students to sit for the Chartered Financial Analyst (CFA) certification.

The 9-month program provides students with advanced training in major areas of finance. Experiential learning (by operating the now \$3.9 million Eberhardt Student Investment Fund) and

data analytical skills are highly emphasized. Courses are offered using an in-person/online Hyflex modality. An extended program duration (up to 2 years) option is available upon assessing students' academic background.

MSF students will benefit from the vast industry network and customized career services offered by the Eberhardt Career Services center. The Eberhardt School of Business is accredited by the Association to Advance Collegiate Schools of Business (AACSB).

OUTCOMES

Employment in the Finance industry is projected to grow much faster than most occupations. Financial Analysts can expect an average compensation of \$81,590 (Bureau of Labor Statistics 2019) ranging up to \$316,000 for portfolio managers (CFA Institute).

REQUIREMENTS

The admission process involves a holistic review of each applicant's background and experiences. The following are required for admission through our online application ([Pacific.edu/ApplyGrad](https://pacific.edu/ApplyGrad)):

- Bachelor's Degree
- Official transcripts
- Resume
- Personal statement
- Two letters of recommendation

For international students, the Test of English as a Foreign Language (TOEFL), International English Language Testing System (IELTS), or Duolingo English Test is required.
